This is the Sponsor Contract Agreement ("Agreement")

2. Sponsor agrees to the sponsorship level of \_\_\_\_\_ and agrees to pay BCCC a fee of \_\_\_\_\_, per the attached Sponsorship Package Options, upon signing the Sponsor Contract Agreement.
3. Sponsor agrees that Sponsor is not the sole or exclusive Sponsor of BCCC and that BCCC shall be entitled to permit any sponsor(s) at its sole discretion.
4. Sponsor agrees that BCCC shall have sole and exclusive control over all aspects of BCCC activities and events.
5. Sponsor agrees to timely provide to BCCC and or its agents, Sponsor's logo, design, concept, artwork, etc., necessary for the jersey, website, banners and or newsletter and as is applicable to the sponsorship level per item 2 above.
6. Sponsor agrees that no inadvertent failure by BCCC to incorporate Sponsor's logo, design, concept, artwork, etc or otherwise reference Sponsor in any manner or location as provided herein shall be deemed a breach of contract, provided BCCC endeavors to cure such failure upon written notification by Sponsor of such failure. Notwithstanding the foregoing, should such failure be material, Sponsor shall be entitled to an equitable reduction in the amount paid.
7. Sponsor and BCCC hereby represent and warrant that each have the right, power and authority to enter into this Agreement, to grant the rights granted herein and to perform the duties and obligations described herein.

8. Sponsor agrees and grants BCCC a limited license to use the Sponsor's logo, design, concept, artwork, etc as necessary and applicable per the sponsorship level per item 2 above.
9. Should any provision of this Agreement be declared invalid, contrary to law or public policy by a Court of Law, the remaining provisions herein shall continue to remain in full force and effect.
10. The validity, enforceability, and interpretation of this Agreement shall be determined in accordance with the laws of the State of California.
11. In the event of any dispute or litigation between Sponsor and BCCC relating to this Agreement, the prevailing party in such dispute or litigation shall be entitled to recover from the non-prevailing party all costs and expenses, including attorney's fees.
12. Sponsor and BCCC agree this Agreement constitutes the sole and complete agreement between Sponsor and BCCC and any other agreements between the parties, whether oral or written, shall be deemed null and void. This Agreement may not be modified or amended except by written instrument duly executed by both Sponsor and BCCC.

We, Sponsor and BCCC, hereby acknowledge that we have read and understand the foregoing Agreement and agree to abide by its terms.
